

BCPT Young Researcher Nordic Prize in Basic & Clinical Pharmacology & Toxicology

The scientific Wiley journal Basic & Clinical Pharmacology & Toxicology (BCPT), owned by the Nordic Association for the Publication of BCPT, calls for candidates to receive the BCPT Young Researcher Nordic Prize in Basic & Clinical Pharmacology & Toxicology. The objective of the prize is to honour the achievements of an outstanding research talent in either of the fields of basic and/or clinical pharmacology or toxicology in the Nordic region.

The prize is for professional use and is worth **7,500 €**.

Pharmacology and toxicology are here understood in the classical sense as the sciences dealing with the influence of drugs or toxic substances, respectively, on living organisms.

The prize is given in honour of work that has been carried out at a public or private research institution in a Nordic country.

Eligible candidates are young, very talented researchers in pharmacology or toxicology, who at the time of the nomination deadline and within the last 8 years have obtained their PhD or achieved equivalent qualifications, and who have demonstrated the ability to carry out original research in pharmacology or toxicology at a high, international level. The date on which the candidate was awarded his/her PhD degree, as stated on the PhD diploma, must be provided in the nomination letter taking parental leave, etc. into consideration. In connection with pregnancy -, maternity -, paternity -, and parental leave after having acquired the PhD degree, the period of 8 years can be extended with the actual number of weeks on leave times two. The period of leave should be stated in the CV.

It is considered an additional qualification if the prize candidate has made important contributions in one or more of the following areas of relevance to pharmacology or toxicology:

- Undergraduate teaching including development of new curricula or teaching forms
- Undergraduate courses
- Research training and supervision
- Editor- and authorships of national and international textbooks

- Editorship of international scientific journals
- Peer reviewing for international scientific journals
- Organizer of postgraduate training courses
- Leadership and active participation in national and international scientific societies
- Organizer of national and international, scientific meetings
- Advisor to national and international regulatory agencies
- National and international policymaking
- Patents and industrial development

*Including the 4 member societies: The Pharmaceutical Society of Denmark, Danish Society for Pharmacoepidemiology, Danish Society of Toxicology and Pharmacology and Danish Society of Clinical Pharmacology.

Each society can propose one or more candidates per year, and the same candidate can be proposed more than once. Nominations should be sent to the national society who will be responsible for the coordinated submission to the BCPT Secretariat.

The nomination of each candidate should be organized in accordance with the criteria listed above and must also contain the candidate's:

- ORCID ID
- Contact details
- Full CV
- Full publication list excluding abstracts
- Copy of the PhD diploma

It is the responsibility of the society to ensure that the candidate - should he or she be selected - is willing to accept the prize. In the selection process, the Board of Directors of BCPT will embrace diversity, equity and inclusion. The announcement of the winner will be published in BCPT.

The prize will be presented at a ceremony at a meeting organized by the national society of the winner. The chairman of the national society will commence by giving a short talk motivating the choice of the candidate. This is followed by a speech by a representative of the Nordic Association for the Publication of BCPT who hands over the diploma. The organization and announcement of the meeting is the responsibility of the national society.

The prize winner should be invited to give a lecture at the meeting. The winner will be invited to write a Focused Review or a Reflective Piece to be published by BCPT in the following year.


BCPT supports a reception for the participants or a dinner for the prize winner and companion, the representative of the Nordic Association, the Editor-in-Chief and members of the executive committee of the organizing society. BCPT determines the maximum amount spent on the dinner or reception.

Deadline for submission of nominations this year has been extended to **1 AUGUST 2024**. The Board of Directors of BCPT select the winner in September.
